For many organisations, this may be the first time that they have seriously reviewed their eligibility for income tax exempt status.  While the organisation’s objects and mission may indicate that income tax exempt is the appropriate registration, it may be that the not-for-profit should be registered as a charity, and outside this new reporting regime. Navigating ‘charitable purpose’ is open to interpretation – there are many nuances that must be considered to ensure the correct registration outcome.  This practical session will not only detail the regulatory reporting changes, but also assist in identifying the signposts to guide practitioners to ensure they recommend the correct type of registration for their clients.

Since 2000, the Conservation Ecology Centre team has restored the woodlands of Cape Otway to support koalas and other native species, undertaken landscape-scale invasive species control programs, conducted critical research in to planned burning to conserve threatened species and mitigate wildfire risk, and developed an ecological research network to share knowledge with land managers. Lizzie has driven several innovative funding models, including establishment and operation of the Great Ocean Ecolodge, and the conception, development and operation of Wildlife Wonders, a unique ecotourism experience that operates as a social enterprise to support the CEC's conservation efforts. In only its second year of operation, Wildlife Wonders was named by National Geographic as

one of the planet's 25 most exciting destinations for 2022. Lizzie received a Medal of the Order of Australia in 2020 for service to conservation and the environment and was awarded the Banksia Foundation's 2005 Prime Minister's Environmentalist of the Year.

**Marla Cowen** is a Senior Associate and charity law specialist. After working in tax at Allens Linklaters, Marla began her charity law career at the Australian Charities and Not-for-profits Commission (ACNC), where she worked as Legal Counsel during the first 4 years of the ACNC's establishment.
