Technical program

On 9 July 2018, the ATO released draft Property and Construction Website Guidance forecasting the rewrite of TR 93/2 (profit making scheme) and associated Rulings and Determinations. This clarification has not occurred so advising on property development transactions remains difficult for partitioners. The ATO Property and Construction Stakeholder Relationship Forum continues to provide further information to the industry. The ATO has also litigated several cases and is actively auditing capital and revenue, CGT small business concession property transactions and SMSF property developments.

This practical workshop will address common property development issues and transactions confronting legal and tax advisers.
